Introductory Notes

This report is intended to define the designated Public Rights of Way (PROWs) in the Parish of Norton St Philip and to identify potential areas of risk and opportunity for the maintenance and possible development of the footpath network in the Parish.

The report is provided to the Area PROW Warden at Somerset County Council and NSP Parish Council, and is based on observations made from Autumn 2023 to Spring 2024.

Reference numbers for PROWs, gates, stiles, bridges, or fingerposts, reflect the designations given on the excellent interactive map, 'Explore Somerset', on the SCC website.

There are 38 designated PROWS in the Parish – 33 footpaths and 5 bridleways (although 3 of these comprise a single route). 28 PROWs are in and around NSP and the remaining 10 are in and around Farleigh Hungerford. 36 PROWs have a designation of FR11/xx (FR11 denoting NSP Parish), whilst the remaining 2 are named BA25/xx for reasons unknown.

The paths are largely numbered in logical groupings, with a few exceptions:

- Paths to and across the Mead are numbered FR11/1 to FR11/5
- Paths extending from Vicarage and Watery Lanes are numbered FR11/7 to FR11/11
- Paths across and extending from Shepherd's Mead and also from Bath Road, are numbered FR11/12 to FR11/19
- Paths extending from Chever's Lane are numbered FR11/20 to FR11/23
- Paths extending from Ringwell Lane towards Hassage and Tucker's Grave are numbered FR11/25 to FR11/27, but also include FR11/37 and BA25/26 and BA25/47
- Paths in the part of Farleigh Hungerford close to Farleigh House are numbered FR11/29 to Fr11/31
- Paths extending from the area around the Castle are numbered FR11/32, FR11/38 and FR11/39
- Paths extending from the lane between Farleigh and Westwood are numbered FR11/33 to FR11/35, plus FR11/40
- There are some missing designations e.g. there is no path FR11/6

In addition to this introduction there are two further sections to the report:

- > A comprehensive summary table giving a brief description of each of the PROWs and a status assessment Green, Amber, Red. Where appropriate, further comments and suggestions of possible actions are given. (However, please note that the status assessments are purely personal interpretations of the prevailing conditions at a particular point in time on this basis 22 are Green, 10 Amber and 6 Red).
- > An appendix providing more detailed explanations of two of the specific risks/opportunities highlighted in the summary table.

FR11/7 and FR11/8 – Status RED (Footpaths from Vicarage and Mackley Lanes)

There are two key issues associated with FR11/7 – a broken stile with a very difficult approach, and beyond this stile a field planted to the edge with maize (Autumn 2023). These issues combine to make this footpath virtually unusable at present.



The approach (from the direction of NSP) to stile #34530 is boggy even in summer, the ground is also very uneven and therefore treacherous in winter months.

It can be seen that someone has attempted to improve the situation by placing a plank of wood, but this is unstable and could in itself become a hazard.

Improvements are required.

The footplate on the stile is broken, which makes it more difficult to negotiate.

This needs to be repaired or preferably replaced with a gate.

The waymark points diagonally across the field in accordance with the Definitive Map, which shows FR11/7 converging with FR11/8 (coming from Mackley Lane) in the middle of the field, and continuing as FR11/8. Older maps show



the field as three smaller bounded fields and in this context the convergence makes sense. However, the trodden path for the continuation of FR11/7 has in recent years been along the western hedge-line leading directly to a stile on the other side of the field. This arrangement appears to have been acceptable to both the landowner and footpath users.



However, in 2023 the field has been planted with maize up to the hedge-line and combined with the hedge growth during the summer, the previously trodden path has been completely lost.




The section of FR11/8 running diagonally across the field from Mackley Lane is also completely compromised.

There is no signage to indicate the start of FR11/8 on Mackley Lane and the field gate is padlocked.

The route of the path is obliterated by the maize crop.

The landowner should be approached to request that footpaths be reinstated and maintained in future, with the possibility of re-routing FR11/8 along the northern edge of the field to join FR11/7 in the northwest corner, with FR11/7 then running along the western field edge, as has been the case recently.



Purple lines show the existing footpaths per the Definitive Map. These were defined when the field comprised three smaller bounded areas.

The field has been completely cropped with maize in 2023 and the paths as shown are impassable.

Blue lines indicate proposed routes around field edges. The proposed route of FR11/7 has been the trodden path in recent years and a stile already exists at position X.

(The path crosses into Hemington parish at position X and becomes FR6/41. This path has also followed the proposed route in recent years)



FR11/19 – Status AMBER (Footpath leading from Norwood Farm to Sparkey's bungalow)

The line of FR11/19 per the definitive map is shown in purple.

The suggested alternative line is shown in blue.

The first section around the edge of the field is an established gravelled track as far as the field gate illustrated, and provides an existing and sensible alternative to the line shown on the definitive map. This is effectively already the trodden path as there is no discernible path on the line of the definitive map, and the field is often protected by an electrified(?) fence.

At the field gate the path passes through an area which in winter months is often extremely muddy and slippery, caused by cattle churning up the ground by the gate.

To avoid this muddy area, it would be possible with agreement to continue the path along to the corner of the field, install a pedestrian gate at position X and sign the footpath along the edge of the next field. The terrain here is pleasant, overlooking an area of bushes and ponds, and would potentially be preferable to the current line for both walker and landowner.
