****LONGMEAD DEVELOPMENT:** The Highways Engineer dealing with this has been away for medical reasons. She is now back and I will continue to chase both sides. I do update the residents regularly.

****FARLEIGH-HUNGERFORD MILL STREAM BRIDGE:** The Bridge Team were in touch in June to confirm the issues around the bridge. I have not heard back but will chase again over the summer.

****BATH RUGBY:** The Planning Team is looking into the legalities of the current situation, which often takes time, but they are eager to move this forward after opening the case which was closed in error. The community are hoping to engage the MP and I will continue to chase.

****FARLEIGH SWIMMING CLUB:** I attended the recent Steering group with the Environment Agency and Wessex Water. There is a lot of data collection happening at the moment and it will take a full 18-month cycle to have all needed statistics to understand where the issues are locally. There has been work with local farmers and the current status of the water is Good. Officially it is still Poor because this is according to the 2024 testing. Until the official 2025 testing status is updated, the Club has been advised they need to keep the official Poor information up, but are able to add their own to assure swimmers that the water is safe at this time. ****Internal Audit Annual Opinion:** Somerset Council has received a “Limited Assurance” rating for the second consecutive year, signalling that key risks and controls still require improvement. The Internal Audit Annual Opinion report notes progress during 2024/25, but not enough to change the overall rating. Auditors remain concerned about financial sustainability, governance, and oversight of major projects. Weaknesses were identified in procurement, budget monitoring, and capital delivery.

****New Interim Chief Finance Officer:** Clive Heaphy started in his role as CFO on the 1st July 2025. He will be in post until April 2026. Clive comes with vast local government experience and we are pleased to have someone in the role, even if just for 9 months. In my role as Opposition Spokesperson for Finance, Procurement & Performance, I will be having regular meetings with him and his team to get a clear understanding of the financial situation our council faces. I know everyone in Somerset hopes that he is able to support the administration to find the savings needed to prevent a Section 114 notice (bankruptcy) within the next 9 months, and beyond.

****Somerset Council Transformation Plan:** Somerset Council has published its *Inspiring Innovation* plan - the second phase of its transformation programme - following £34m in staff redundancies delivered under Phase 1. This new plan is intended to plug a projected £101m budget gap in 2026/27, rising to £190m by 2029/30. The delivery of Phase 2 will require

****Boundary Review Draft Proposals Published:** The Local Government Boundary Commission for England has published draft recommendations for Somerset Council's new electoral divisions. The proposals reduce the number of Somerset councillors from 110 to 96, creating 96 single-member divisions across the county. All current boundaries would be redrawn. A public consultation on the draft recommendations runs until 11 August 2025. Final proposals are due in December, with changes expected to take effect at the May 2027 elections. ****Safeguarding Review Following Resident's Death:** A safeguarding adults review has been published following the death of a Somerset resident, "Hazel," who died in 2019 after choking on food not prepared in line with her care plan. The Somerset Safeguarding Adults Board (SSAB) has issued a series of recommendations to improve how care risks are recorded, shared, and managed - particularly in relation to choking risks, autism-specific care, agency staff training, and inter-agency coordination. The review highlights the need for improved legal literacy, better oversight of provider performance, and consistent dysphagia training. ****Youth Parliament Nominations Now Open:** Nominations are now open for the 2025 Youth Parliament elections in Somerset. Young people aged 11–17 who live or study in the county can stand for election to become a Member of Youth Parliament (MYP), representing Somerset at a national level. Three MYPs will be elected to lead campaigns and work with local organisations to raise young people's voices. The deadline for nominations is Monday 3 November 2025, with elections taking place in December.
